What information we collect, use, and why

We collect or use the following information to provide patient care, services, pharmaceutical products and other goods:

- Name, address and contact details
- Date of birth



We collect or use the following personal information **for patient app or portal functionality**:

- Names and contact details
- Information used for security purposes

We collect or use the following personal information **to comply with legal requirements**:

- Name
- Contact information

We collect or use the following personal information for information updates, marketing or market research purposes:

We collect or use the following personal information for dealing with queries, complaints or claims:

Lawful bases and data protection rights

Under UK data protection law, we must have a "lawful basis" for collecting and using your personal information. There is a list of possible lawful bases in the UK GDPR. You can find out more about lawful bases on the ICO's website.

Which lawful basis we rely on may affect your data protection rights which are in brief set out below. You can find out more about your data protection rights and the exemptions which may apply on the ICO's website:

- Your right of access You have the right to ask us for copies of your personal information. You can request other information such as details about where we get personal information from and who we share personal information with. There are some exemptions which means you may not receive all the information you ask for. You can read more about this right here.
- Your right to rectification You have the right to ask us to correct or delete personal information you think is inaccurate or incomplete. You can read more about this right here.
- Your right to erasure You have the right to ask us to delete your personal information. You can read more about this right here.
- Your right to restriction of processing You have the right to ask us to limit how we can use your personal information. You can read more about this right here.



- Your right to object to processing You have the right to object to the processing of your personal data. <u>You can read</u> more about this right here.
- Your right to data portability You have the right to ask that we transfer the personal information you gave us to another organisation, or to you. You can read more about this right here.
- Your right to withdraw consent When we use consent as our lawful basis you have the right to withdraw your consent at any time. You can read more about this right here.

If you make a request, we must respond to you without undue delay and in any event within one month.

Our lawful bases for the collection and use of your data

Our lawful bases for collecting or using personal information to provide patient care, services, pharmaceutical products and other goods are:

• Contract – we have to collect or use the information so we can enter into or carry out a contract with you. All of your data protection rights may apply except the right to object.



Our lawful bases for collecting or using personal information for patient app or portal functionality are:

- Consent we have permission from you after we gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.
- Legitimate interests we're collecting or using your information because it benefits you, our organisation or someone else, without causing an undue risk of harm to anyone. All of your data protection rights may apply, except the right to portability. Our legitimate interests are:
 - Personal data collected and used for personal exercise programmes allows the individual to access exercises, videos and diaries to monitor their progress and improve compliance.

Our lawful bases for collecting or using personal information to comply with legal requirements are:

 Legal obligation – we have to collect or use your information so we can comply with the law. All of your data protection rights may apply, except the right to erasure, the right to object and the right to data portability.



Our lawful bases for collecting or using personal information for information updates, marketing or market research purposes are:

- Legitimate interests we're collecting or using your information because it benefits you, our organisation or someone else, without causing an undue risk of harm to anyone. All of your data protection rights may apply, except the right to portability. Our legitimate interests are:
 - Able to update patients on changes to prices promptly

Our lawful bases for collecting or using personal information for **dealing with queries, complaints or claims** are:

 Consent - we have permission from you after we gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.

Where we get personal information from

- Directly from you
- Family members or carers



How long we keep information

Care Records for Adults	8 years after the conclusion of treatment or death, as recommended by the British Medical Association
Care Records for Children	Retain until the patient's 25th birthday or 26th if young person was 17 at conclusion of treatment, or 8 years after death, as recommended by the British Medical Association
Records Related to Sales (e.g invoices, receipts etc)	6 years as required by HMRC

Who we share information with

With your consent, we share personal information with:

- Other health providers (eg GPs and consultants)
- Insurance companies, brokers and other intermediaries
- Organisations we need to share information with for safeguarding reasons
- Emergency services



- Publicly on our website, social media or other marketing and information media
- Suppliers and service providers

Duty of confidentiality

We are subject to a common law duty of confidentiality. However, there are circumstances where we will share relevant health and care information. These are where:

- you've provided us with your consent (we have taken it as implied to provide you with care, or you have given it explicitly for other uses);
- we have a legal requirement (including court orders) to collect, share or use the data;
- on a case-by-case basis, the public interest to collect, share and use the data overrides the public interest served by protecting the duty of confidentiality (for example sharing information with the police to support the detection or prevention of serious crime);
- If in England or Wales the requirements of The Health Service (Control of Patient Information) Regulations 2002 are satisfied; or
- If in Scotland we have the authority to share provided by the Chief Medical Officer for Scotland, the Chief Executive of NHS Scotland, the <u>Public Benefit and Privacy Panel for</u> <u>Health and Social Care</u> or other similar governance and scrutiny process.
